The evaluation of the Annual Reports will be done as per the criteria set out by the Institute of Chartered Accountants of Nepal (ICAN) which are in line with the criteria outlined by South Asian Federation of Accountants (SAFA) for evaluation of Best Presented Accounts and Corporate Governance Award at SAFA level. .

The winner will be announced on the occasion of the Oath Taking Ceremony of the newly elected President and Vice President of the Institute in July 2019. The recipients of the National BPA Awards shall have the privileges for nomination in the SAFA Best Presented Annual Report Award 2018.

Organizations having the Financial Report based on Nepal Financial Reporting Standards (NFRS) are requested to send their interest for participation along with 6 copies of their annual reports (preferably in English) for the fiscal year 2017/18 (2074/75) distributed and duly approved by their annual general meeting to the ICAN office located at ICAN Marg, Satdobato, Lalitpur latest by 29 May, 2019 (corresponding to 15 Jestha, 2076).

This is to inform all concerned that National Best Presented Annual Report Award winners have also won awards in the SAFA level.
